OFFICE MEMORANDUM

Sub:- **Implementation of the Hon'ble Supreme Court of India's Order dated 04-09-2012 in IA No.9 of 2010 in Transfer Petition (C) No.56 of 2007 – Union of India and others v/s N.K. Nair and others – circulated by Ministry of Defence.**

CDA (O), Pune has sought the consent of Survey of India vide their letter No.PR Cell/Gen/Survey of India, dated 10-10-2014 (copy enclosed) on the following points for working out Rank Pay Arrears of Army officers :-

- (i) The rank pay arrears will be worked out on Army rates of pay only and not on civil rates of pay.
- (ii) The fixation of pay will be carried out based on the available service particulars of same batch and same rank and not on 2 above and 2 below formula.

The above is brought to the notice of all the concerned, if any officer, serving or retired has any objection on the method of calculation of rank pay arrears as stated against points (i) & (ii) above, he may file his objection within 30 days of date of this O.M. If no objection is received within 30 days, it will be assumed that no officer (serving or retired) has any objection on the above cited method of calculation of arrears and accordingly consent of Survey of India will be conveyed to CDA (O), Pune as desired by them.

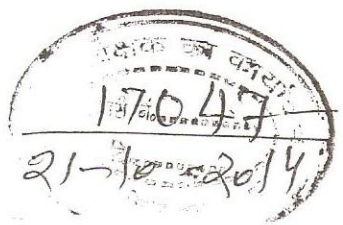
With reference to the above cited letters it is intimated that out of 117 affected
officers, the service particulars and the period of service in SOI as well as Army of 38
officers only received in this office. Working out arrears and the related work is under
process.

The service particulars of other 79 officers are still awaited. Please find
enclosed a copy of 79 officers list whose service particulars are not available with this
office. Please forward the same at an early date to workout the arrears. In the list, the
details of bankers of he officer at SI.No.49 are not received in this office. The same may
please be intimated to the officer. The officer at SI.No. 51 have retired from service on
6/6/1984 and hence, he is not entitled for rank pay arrears. Officer's Personal No., CDA
(O) A/c No. and name of the officer are not matching at SI.No.64. Please rectify and
intimate the same for further necessary action.

In this context, the competent authority has asked to take consent for the
following points from Survey of India.

- (a) Almost all the payments have been made based on the Service particulars
received from AHQ., New Delhi and wherever the Particulars of the officers
have been received from Survey of India the cases are under review and arrears
will be worked out on Army rates of pay only and not on civil rates of pay.
- (b) As stated in the above letters, the total arrears will be worked out and will be
paid by this office. But the arrears paid for the period for which the officers
were on secondment to Survey of India is required to be remitted by SOI
through book adjustment to regularise the paid arrears for which consent of
Survey of India is required.



- (c) Further correspondence on pay fixation matter of those officers who were retired from SOI has to be made by SOI itself. Revised LPCs, wherever necessary will be issued by this office. This office will inform the status of processing of cases to SOI.
- (d) The matter regarding carrying out of fixation of pay as per Army scales of pay and not on Civil rates of pay is required to be communicated to all affected officers by SOI.
- (e) The fixation of pay will be carried out based on the available service particulars of same batch and same rank officer and not on 2 above and 2 below formula.

The work will be commenced on receipt of consent for all the above Paras (a) to (e) from Survey of India.
