3. The demand draft for ₹ 10,000/- as E.M.D. in favour of Senior Pay & Accounts Officer, CP&AO, Dehradun payable at Dehradun is to be attached with the tender. However firms exempted for E.M.D. need not to submit.
4. Your tender will not be considered if received after 14:00 hours on 12/01/2016.
5. Sample of minimum one unit of each item is required. Without Sample, Quotation cannot be entertained.
6. Supply to be delivered within twenty days of Supply Order. No further extension will be granted.
7. **Performance Security**  
Successful bidder will have to furnish performance security @ 10%(Ten percent) of the value of the contract awarded with each Directorate of SOI office at Dehra Dun. The performance security should be in shape of Account Payee Demand Draft, Fixed Deposit Receipt/Bank Guarantee of any Nationalized bank of Dehra Dun drawn in the favour of "Senior Account Officer" CP&AO, Dehradun.
8. **DELIVERY :**  
(i) In case of local firms : Prices to include delivery charges at the consignee's office and should be inclusive of all taxes. These taxes will not be paid separately.  
(ii) In case of firms situated outside station : Prices should be FOR Dehradun. Your rate should not exceed the Govt. approved rates.
