## TERMS & CONDITIONS

1. The tender should be submitted in a sealed envelope duly marked as "TENDER FOR SALE OF UNSERVICEABLE STORES DUE ON 23-12-2016 (1300 hrs)".
2. The tender document can either be purchased from **E&AO APGDC, Survey of India, Hyderabad** on payment of Rs 100/- in cash or in form of D.D. drawn in favor of **E&AO , Survey of India, APGDC, Hyderabad** or can be Downloaded from survey of India website [www.surveyofindia.gov.in](http://www.surveyofindia.gov.in) and in such case the tenderer has to pay the tender document cost in form of D.D. for Rs 100/- drawn in favour of the **Establishment & Accounts officer, Survey of India, APGDC, Hyderabad**, which is to be enclosed with the tender , failing which the tender will not be accepted.
3. The tender duly signed by the tenderer should be addressed to the "**Director, APGDC, Survey of India, Uppal, Hyderabad-500039**" and can be dropped in the office tender Box placed at the main entrance or may be sent to this office by post which should reach on or before 23-12-2016(1300 hrs). The Director, **APGDC, Survey of India, Uppal** is not responsible for any postal delay or non receipt of tender by due date and time for any reason whatsoever.
4. Earnest Money Deposit: Earnest Money of Rs 2000/- (Rs Two Thousand only) should be deposited along with the sealed tender in the shape of Demand Draft drawn in favor of **E& AO, APGDC, Survey of India, Hyderabad** failing which tender will not be accepted.
5. Earnest Money will be returned to the unsuccessful bidders and no interest will be paid for the same.
6. The rate should be quoted in words, as well as in figures (In Indian Rupees only). No correction or over writing in the quotation will be allowed.
7. Tender should be submitted under sealed cover only.
8. The tender shall remain valid for 90 days from the date of opening of the tenders.
9. If any amount is payable on account of VAT, Sale Tax or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate . All such taxes shall be deposited directly with concerned authority and challan(s) to be submitted to this office by the successful bidder at the time of delivery of the unserviceable stores.
10. Bidder if so desires may be present at the time of opening quotations/ tender.
11. **NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.**
12. Only the highest offer will be accepted.
13. Successful bidder will have to deposit the full amount of unserviceable stores plus the applicable taxes within 48 hours of the acceptance of his/her offer.



14. Items once disposed to the successful bidder shall **not** be taken back by SOI under any circumstances.
15. The successful bidder shall be required to lift all the items from the survey of India, APGDC, Hyderabad premises to his site within 5 days during working hours after payment of the bid amount. In the event of failure to do so, survey of India shall have full right to forfeit the Earnest Money of the bidder. Permission to lift the material on gazetted holidays or non working days will not be granted under any circumstances. EMD will be refunded only after bidding items are lifted from the office.
16. For the final evaluation, the highest bidder shall be chosen based on the amount quoted and fulfilling tender conditions and the same offer will be notified to the successful bidder.
17. No assistance whatsoever shall be provided by survey of India for lifting the items. The successful bidder shall make his own arrangements of labour and vehicles etc. for shifting the materials to his site, at his own cost. No sorting out will be allowed and no scrap materials are to be left in the office premises. If any material is not lifted then the EMD will be forfeited. No separate terms & conditions are to be mentioned by the bidder.
18. **The Director, APGDC, Survey of India, Hyderabad has the right to cancel the tender proceedings at any stage without assigning any reason thereof.**
