2. Earnest Money will be returned to the unsuccessful bidders and no interest will be paid for the same.
3. Quotation should be submitted under sealed cover only.
4. Quotation should be addressed to The Director, TNP&ANI GDC, Survey of India, Block – III, Electronics complex, Thiru.vi.ka Industrial Estate, Guindy, Chennai-600032, and can be dropped in the office Tender box placed at Office Building Entrance.

6. The rate should be quoted in words as well as in figures No correction or over writing in the quotation will be allowed while quoting the rate, tax component should invariably be shown separately.

8. If any amount is payable on account of VAT, Sale Tax or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. 11. The Director, TNP&ANI GDC, Chennai reserves the right to reject or accept any quotation without assigning any reasons thereof.
12. **NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.**
13. Only the highest offer will be accepted.
14. Successful bidder will have to deposit the full amount of Bid value of unserviceable stores plus the applicable taxes within 2 working days of the acceptance of his offer.
15. Items once disposed to the successful bidder shall **NOT** be taken back by **SOI** under any circumstances.
16. The successful bidder shall be required to lift all the items from the Survey of India, TNP&ANI GDC, Chennai premises to his site within 5 working days during working hours after payment of the bid amount. In the event of failure to do so, Survey of India shall have full right to forfeit the Earnest Money of the bidder.
