**Tender box** kept in the store Section up to 11-10-2017 (12: 00 Hrs.) or to be sent by Registered Post.

3. If tender is submitted by Registered post, sealed envelope should be duly marked as “ To be opened in presence of Board Members” and to be sent in another outer envelope.
4. The Director, TMMz GDC, Survey of India, Silchar will not be responsible for any postal delay or loss and bid received after last date and time of receiving bids are liable to be rejected.
5. Tender must be accompanied by Earnest money of Rs.5,000/- (Rupees Five thousand only) in the shape of Demand Draft in favour of “ **D.D.O TMMz GDC, Survey of India**” payable at Silchar. Without earnest money the tenders will be rejected.
6. Tenders received after stipulated date and time shall not be considered.
7. The amount should be quoted both in figure and words. No correction or overwriting in the quotation should be made.
8. Each page of the tender document should be duly signed by the tenderer. Incomplete or unsigned tenders are liable to be rejected.
9. Amount payable on account of GST at appropriate rate towards sale/transaction shall be paid by the successful tenderer in addition to the quoted rate. GST shall be deposited by the successful tenderer directly to the concerned authority and copy of such challan(s) shall be submitted to O/o. Director, TMMz GDC, Survey of India, Silchar before taking delivery of the condemned Vehicles.
10. Name and address of the tenderer with Telephone/Cell No. should be mentioned in the tender document.
11. The tender shall remain valid for 60 days from the date of opening the tenders.
12. Tenderer if, so desires may be present on the date and time of opening the tenders.
13. Acceptance of the offer will be notified to the successful tenderer as soon as decided by the Board.

14. The successful tenderer will have to deposit the full amount quoted in the tender form within 7 (seven) days from the date of notification of acceptance and will take away the subject vehicle from Survey of India premises within 5 (five) days from the date of deposit of the amount after obtaining due permission. Permission to take away the vehicles on Gazetted Holidays or non-working days will not be granted under any circumstances.
15. If the tenderer fails to deposit the amount within the stipulated time, the earnest money will be forfeited and no further correspondence will be entertained by this Office.
16. The successful bidder shall have to make its own arrangements of labour and vehicle etc for shifting the vehicles to his site, at his own cost. No sorting out will be allowed and no part of the subject vehicle is to be left behind in the office premises. If any part/material is not lifted then the deposited EMD will be forfeited.
17. The Tender Acceptance Form / Certificate, attached as **Annexure-1**, duly filled in and signed by the tenderer should be attached alongwith quotation as a mark of acceptance of the terms and conditions.
18. The Director TMMz.GDC reserves the right to reject any or all the quotations without assigning any reasons thereof.
