7. The tender shall remain valid for 90 days from the opening date of tender.
8. If any amount is payable on account of GST or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. All such Taxes shall be deposited directly with the concerned authority and challans to be submitted to this office by the successful bidder at the time of delivery of the condemned stores.

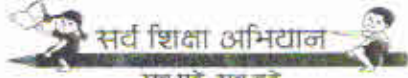
