

Without EMD Tender will be rejected.
- 2. Earnest Money will be returned to the unsuccessful bidder and no interest will be paid for the same.
- 3. Separate Quotation for each Lot should be submitted under sealed cover only.
- 4. Quotation should be addressed to The Director MA&DC Survey of India Hathibarkala Dehradun 248001 and can be dropped in the office Tender box only.

- **6.** The rate should be quoted in words as well as in figures No correction or over writing in the quotation will be allowed. The rate, tax component should invariably be shown separately.
- 7. The tender shall remain valid for 90 days from the opening date of tender.
- 8. If any amount is payable on account of GST or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. All such Taxes shall be deposited directly with the concerned authority and challans to be submitted to this office by the successful bidder at the time of delivery of the condemned stores.
- **9.** The bid amount which will be deposited in the treasury of Central Government will be exclusive of taxes mentioned at SL.No.8 above.
- **10.** Bidder, if so desires may be present at that time of opening quotations. They can also enquire about the status of their tender over telephone.
- 11. NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.
- 12. Only the highest offer will be accepted.
- **13.** Successful bidder will have to deposit the full amount of Bid value of unserviceable store plus the applicable taxes within 48 hrs. of the acceptance of this offer.
- 14. Items once disposed to the successful bidder shall NOT be taken back by SOI under any circumstances.
- 15. The successful bidder shall be required to lift all the items from the Survey of India Hathibarkala Estate within 5 days during working hours after payment of the bid amount. In the event of failure to do so, Survey of India shall have full right to forfeit the Earnest Money of the bidder. Permission to lift the material on Gazzetted holidays or non-working days will not be granted under any circumstances. EMD will be refunded only after bidding items are lifted from the office/khamal premises.
- 16. Tenders received after the stipulated date and time shall not be entertained under any circumstance whatsoever including postal delays, etc.

17. For final evaluation the highest bidder shall be chosen based on the amount quoted and fulfilling tender conditions.

18. No assistance whatsoever shall be provided by Survey of India lifting the items. The successful bidder shall have to make his own arrangements for shifting/lifting the materials to his site, at his own risk and own cost. No sorting out will be allowed and no scrap materials are to be left in our premises. If any material is not lifted within the stipulated/permitted period then the EMD will be forfeited.
