1.0 PARTICULARS OF THE TENDER

2.0 TENDERING PROCESS:

The tender will be as per following :-

- (i) Bid – It shall contain the scanned copy of the following :-
- (a) Copy of EMD
 - (b) GST registration certificate
 - (c) Tender acceptance letter (annexure 'B')
 - (d) Undertaking for non-blacklisting and non-registration of criminal case
 - (e) Scanned copy of latest ITR of the firm/bidder
 - (f) Scanned copy of undertaking that the firm/bidder will not sublet/transfer the contract to any other firm
 - (g) If vehicle is scrapped by the buyers scrap certificate should be handed over to this Directorate.

3.0 OTHER TERMS AND CONDITIONS

- (i) The bids can be submitted to the office by hand or can be sent through speed post/ courier.
- (ii) The rates should be quoted in the format annexed as annexure 'A'.
- (iii) Please note that incomplete bids/ late bids/ Delayed bids or Postal Delayed bids will not be considered at all. Any bid received by the Addressee after the dead line for submission of tender will be returned to the bidder un-opened.

- (iv) The bidder may please note that the bid once submitted will not be allowed to alter. The bid should not have any scope of ambiguity, cutting or overwriting. For inadvertent mistake, if any, the bidder must strike through erroneous figure/ word and legibly write the correct figure / word and must be authenticated with dated signature of the tenderer.
- (v) Both the vehicles will be disposed-off to the successful bidder/bidders.
- (vi) The prospective bidder has to submit authenticated documentary proof of his address.
- (vii) The unserviceable vehicles can be inspected on any working day from 21-02-2020 to 06-03-2020 between 10 am to 04 pm in the premises of Survey of India, 2nd Floor, Wing No. IV, West Block4, R.K. Puram, New Delhi-110066. A prior intimation must be sent on email delhi.gdc.soi@gov.in for inspection clearly indicating the date and time of arrival.
- (viii) Bidders should take into account any corrigendum published before submitting their bids.
- (ix) Interested bidders has to submit original EMD in the form of DD/BG only, of ₹ 20,000 (₹ Twenty Thousand) only in favour of E&AO, DSA & DGDC payable at Delhi on the following address. The EMD should reach before the date of opening of the bid otherwise the bid will be considered as nonresponsive.

- (x) The EMD of the unsuccessful bidders will be returned within 15 days from the date of opening of bid except for H1 (first highest bidder) and H2 (second highest bidder). No interest will be paid for the same.
- (xi) The highest bidder will have to deposit entire auction value with applicable taxes within 02 days from the date of issue of sale letter.
- (xii) The H1 bidder will have to deposit GST as applicable on the entire bid value with the concerned authority and a copy of the deposit slip/challan have to be submitted in the office before lifting the store items.
- (xiii) The Earnest Money Deposit (EMD) of the successful bidder shall be returned after depositing in full payment and removal of items from the premises.
- (xiv) No items, once disposed to the successful bidder, shall be taken back, on any condition whatsoever.
- (xv) The successful bidders shall be required to lift the items at his own cost from the disposal site to his premises within two days (between 10.00AM to 4.00PM) after making full payment. On failure to do so, the office shall have the right to forfeit entire amount of the bidder. Segregation of material is not allowed in the premises.

(xvi) In case the highest quoting firm (H1 bidder) fails to honor the bid, the next opportunity will be given to the next highest quoted eligible bidder (H2 bidder) and the EMD & Bid Value of the H1 bidder will be forfeited and no representation will be considered in this matter.

(xvii) The board reserves the right to accept or reject any or all quotations without assigning any reason whatsoever. The decision of the board will be final and binding on the tenderer.

(xviii) In case of any dispute to any aspect of the bid between the two parties, the decision of DSA & DGDC shall be final and binding on both the parties.

(xix) The envelope should be sealed and properly super scribed. The envelope should be addressed as below and NOT to any individual by name.
